Answer The Minister of State in the Ministry of Finance (Shri Santosh Kumar Gangwar)

- (a): No, Madam.
- (b): Does not arise.
- (c): In order to help the sugar industry to improve their liquidity position and thereby facilitate clearance of cane price arrears of farmers, the Government has undertaken the following interventions:
- i. Provided Incentive of Rs.484 crore on Raw Sugar Export during sugar seasons 2013-14 and 2014-15 for evacuation of excess stocks of sugar in the country.
- ii. Extended interest free loan of Rs.6521 crore during sugar season 2013-14 under the Scheme for Extending Financial Assistance for Sugar Undertakings (SEFASU).
- iii. Extended soft loan of Rs.4305 crore during 2014-15 sugar season.
- iv. Facilitated sugar mills for supply of ethanol under Ethanol Blended Petrol (EBP)Programme to achieve enhanced ethanol blending target by fixing remunerative price and waiving off excise duty on supply of ethanol during 2015-16 sugar season.
- v. Providing Performance based Production Subsidy @ Rs.4.50 per quintal of cane crushed during current sugar season 2015-16 to offset cane cost and timely clearance of cane dues of farmers.

STATEMENT REFERRED TO IN REPLY TO PARTS (a) & (b) OF THE STARRED QUESTION NO. *25 DUE FOR ANSWER ON 05.02.2019 IN THE LOK SABHA

(a) & (b) With a view to find long term solutions for sugarcane and sugar industry so as to rationalize their dependence on state assistance while at the same time encourage farm diversification to reduce adverse impact on the water sector, a task force on Sugarcane and Sugar Industry has been constituted in December, 2018 by NITI Aayog under the Chairmanship of Prof. Ramesh Chand, Member, NITI Aayog.

Sugar production in India has been cyclic in nature. Every few years of high sugar production are followed by low production periods. surplus phase, ex-mill price of sugar in domestic market gets depressed leading to low realization resulting in accumulation of cane price arrears of farmers. Interventions by Government are therefore, required from time to time to improve liquidity of sugar mills thereby enabling them to clear cane price dues of farmers. However, during last ten months, apart from various short-term interventions, the Government has taken few long-term measures to address the issue of regular intervention by Government. One such measure relates to fixation of Minimum Selling Price (MSP) of sugar which will facilitate a minimum price to sugar mills to recover the cost of cane and minimum cost of conversion in surplus seasons. Further, Government has allowed production of ethanol from B-heavy molasses and from cane juice which will help diversion of sugar for production of ethanol in surplus seasons. Government has also brought out a scheme for assistance to sugar mills to enhance the ethanol production capacity in the country. These measures are expected to minimise the support required by the sugar industry from Government.

THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRI-CULTURE, COMMUNITÝ DEVE-**LOPMENT** AND COOPERATION (SHRI ANNASAHEB SHINDE): (a) and (b) During the last three years (from 1-1-66 to 31-12-68) letters of intent were issued for the establishment of 15 new sugar factories and expansion in 12 existing units. The names of the parties and the additional daily cane crushing capacity sanctioned for each sugar factory are given in the attached Statement. [See Appendix LXVII, Annexure No. 35.]

(c) and (d) Except for the establishment of two new cooperative sugar factories at Sangamner, District Ahmednagar in Maharashtra and at Madhi, District Surat in Gujarat (S. Nos. 5 and 8 of the attached Statement), all the other schemes are in the various stages of implementation. Generally it takes about three years from the date of the issue of letter of intent for the establishment of additional capacity licensed, because the entrepreneurs have to raise capital and arrange for plant and machinery. Wherever a party fails to implement the scheme, necessary steps are taken for the cancellation of the letter of intent or the revocation of the licence granted to it.

ANSWER

MINISTER OF AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री (SHRI NARENDRA SINGH TOMAR)

(a) to (c): Department of Agriculture & Farmers Welfare is implementing sugarcane development programme under National Food Security Mission (NFSM) in 13 major sugarcane growing states viz., Andhra Pradesh, Bihar, Gujarat, Haryana, Karnataka, Madhya Pradesh, Maharashtra, Odisha, Punjab, Telangana, Tamil Nadu, Uttarakhand & Uttar Pradesh from 2014-15 with an aim for enhancing production and productivity. Sugarcane production has increased from 352.14 million tonnes during 2013-14 to 468.79 million tonnes in 2022-23 (2nd Advance Estimates). Apart from production of sugar, the sugarcane & its byproducts are used for production of ethanol.

Government is implementing Ethanol Blended Petrol (EBP) programme with multiple objectives of reducing import dependency, savings in foreign exchange, providing boost to domestic agriculture sector and for associated environmental benefits. Apart from sugarcane & its byproducts, the production of ethanol has been allowed from a variety of feedstocks like agricultural residues, less water consuming crops like maize, damaged foodgrains, surplus FCI rice, etc.
